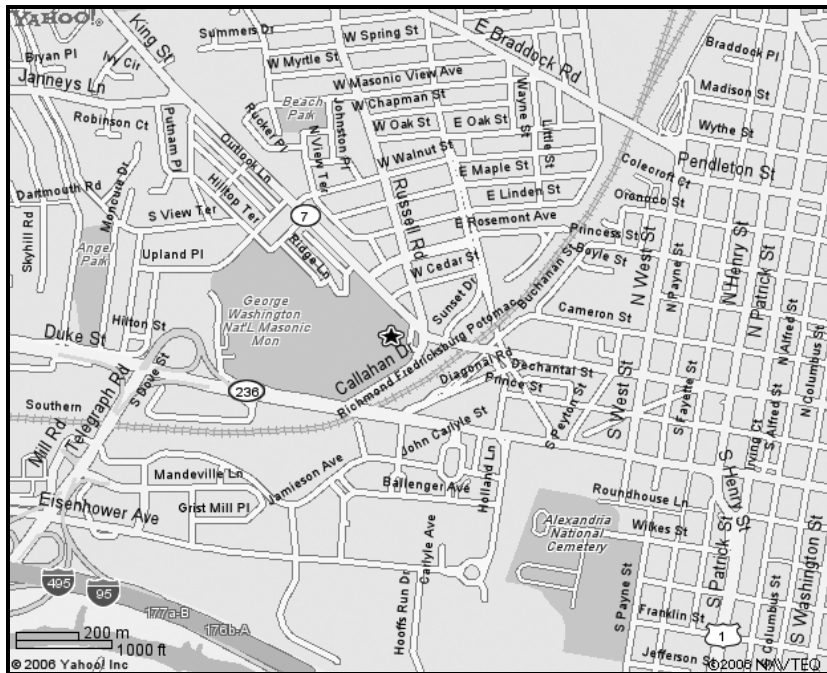

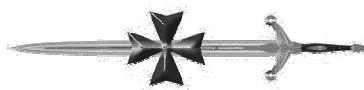

BY-LAWS

As approved by the
Grand Commandery of the Commonwealth of Virginia
March 24, 2004

Article I: The Stated Conclaves of Old Dominion Commandery No. 11 shall be held at George Washington Masonic National Memorial located at Alexandria, VA on the 4th Wednesday month at 7:30 PM.

Article II: Every member of this Commandery except the Commander, Treasurer, Recorder and Prelate shall be charged \$35.00 annual dues plus Per Capita Taxes and Assessments, with the total amount payable rounded up to the nearest whole dollar.

Article III: The fee for the Orders of Knighthood shall be \$130.00. The fee for Affiliating with this Commandery shall be \$30.00.

Article IV: The Treasurer shall receive an annual compensation: \$100.00.

Article V: The Recorder shall receive an annual compensation: \$300.00.

Article VI: The Sentinel shall receive an annual compensation: \$5.00 for each conclave he attends in that capacity.

Article VII. Three Trustees shall be elected by the Commandery, and they shall, at the Annual Stated Conclave in March, make a report of the investment of all funds and the condition of property entrusted to their care.

Article VIII: All contributions to the philanthropic programs and all donations for specific purposes shall be identified separately and accounted for as restricted funds to be paid out by the Treasurer as the Commander of the Commandery shall direct, except that these funds shall not be used for any purpose other than that for which donated or contributed.

Article IX: Any amendment proposed to these bylaws shall be submitted in writing, lie over for one month, the membership be notified of pending action thereon, and shall require a two-thirds affirmative vote of the members present for its adoption.

STANDING RESOLUTIONS

As approved and updated by
Old Dominion Commandery No. 11
February 22, 2006

Resolution No. 1 – Trustees

There shall be three (3) Trustees of this Commandery, one of whom shall be elected annually for a three year term. In the case of a vacancy for any cause, the Commander shall order an election to fill the un-expired term of the such vacancy after giving the Sir Knights due notice thereof. It shall be the duties of the trustees to invest and reinvest such sums as are made available by the Commandery; and to make such reports as are deemed necessary to keep the Commandery apprised of these matters. (Adopted by vote of the Commandery, January 21, 1983.)

Resolution No. 2 – Dual Membership

Any Knight Templar who is a member in good standing of Old Dominion Commandery No. 11 may petition for and hold membership in any other Commandery of Knights Templar under the jurisdiction of the Grand Encampment of the United States of America where such dual membership is permitted under the statutes and bylaws of that jurisdiction. (Adopted by vote of the Commandery, January 21, 1983.)

Resolution No. 3 – Life Membership Fund

Purchase of life membership in this Commandery is no longer available. All Life Memberships purchased prior to November 21, 1980 shall remain in effect for the life of the member. The Life Membership Fund as of November 21, 1980 shall be continued under the control of the Trustees for investment; the return therefrom shall be available to the Commandery for working funds as needed. (Adopted by vote of the Commandery, January 21, 1983.)

Resolution No. 4 – Annual Dues Notices

The Recorder shall mail dues bills for the ensuing year, not later than the 20th of November each year. (Adopted by vote of the Commandery, January 21, 1983.)

Resolution No. 5 – Uniforms

This resolution was REVOKED by vote of the Commandery, May 21, 1993.

Resolution No. 6 – Loaning of Commandery Property

The property and costumes of Old Dominion Commandery No. 11 used in the conferral of Orders shall not be loaned to any individual or organization. (Adopted by vote of the Commandery, November 16, 1990.)

Resolution No. 7 – Review of Budget

The incoming Commander shall present his proposed budget for the succeeding year to the Trustees in session for review not later than the February Stated Conclave of the Commandery. (Adopted by vote of the Commandery, November 16, 1990.)

Resolution No. 8 – Investment Account Interest

Half of the interest income accrued from the investment accounts held by the Trustees shall be provided to the Commandery's general fund. The remaining half shall be rotated back into the principal for continued investment growth. (Adopted by vote of the Commandery, February 22, 2006.)
